
SECTION I. INVITATION TO BID

Supply and Delivery of One (1) Unit Brand New Pickup Truck

1. The Guimba Water District (GWD) through the authorized appropriations under the FY 2020 General Appropriations Act intends to apply the sum of **One Million Three Hundred Thousand Pesos and 00/100 (Php1,300,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Project, **"Supply and Delivery of One (1) Unit Brand New Pickup Truck"**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The GWD now invites bids for the purchase of **Supply and Delivery of One (1) Unit Brand New Pickup Truck**. Delivery of the goods shall be in accordance with the Delivery Schedule under Section VI. Schedule of Requirements. Bidders should have completed, within two (2) years from the date of the Pre-Bid Conference, contracts similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act."
4. Interested bidders may obtain further information from the GWD Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below during office hours from 8:00 AM. to 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders from August 28, 2020 to September 23, 2020 from the address below and upon payment of a non-refundable fee in the amount of **Five Thousand Pesos (P5,000.00)**. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the GWD, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
6. The GWD will hold a Pre-Bid Conference on September 9, 2020, 1:00 PM at the GWD Office, Danzalan St. Cor Faigal St., Sta. Veronica District, Guimba, Nueva Ecija, which shall be open to all interested parties.
7. Bids must be delivered to the address below on or before September 23, 2020, 12:00 Noon. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.
8. Bid opening shall be on September 23, 2020, 1:00 PM. at the GWD Office, Danzalan St. Cor Faigal St., Sta. Veronica District, Guimba, Nueva Ecija. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
9. The bidders shall drop three (3) copies of their duly accomplished eligibility and technical requirements, and the financial component of the bid in two (2) separate sealed envelopes in the bid box located at the above-mentioned address.
10. The GWD reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
